This contract is entered between _____ (Herein after "Seller") and
_____ (Herein after "Buyer").

Deposits: A \$250.00 USD non-refundable deposit is required for said purchase of dog described above. A deposit is considered a binding contract indicating that the Buyer agrees to purchase the puppy.

Payment Options: Cash, PayPal or Cashier's Check. All fees include sale price and shipping/transportation, if applicable, and are required prior to the delivery of the dog.

All dogs sold with Limited AKC registration are required to be spayed/neutered before one year of age. Proof of spay/neuter is required. We are responsible breeders and encourage spay/neuter programs.

This dog is guaranteed to be a purebred Havanese and is the offspring of AKC registered parents. The dog can be registered on Limited or Full terms as indicated and agreed upon by the Seller. The AKC Registration papers will be provided to Buyer from Seller at time of adoption or as soon as received from AKC Registry Service. No guarantees are made as to size, color or build of dog. Seller is not responsible for dog's ability to breed, litter size or quality of puppies produced. It is the Buyer's responsibility for veterinary bills or other services incurred, should Buyer choose to breed fully AKC registered Havanese dog.

Buyer agrees to provide a life-long commitment, comfortable indoor environment, prompt medical attention, proper grooming and responsible care. This includes keeping the dog parasite free and up to date with vaccinations, proper nutrition, exercise and fresh water available at all times. The Buyer promises to provide a safe environment for the dog, and never allow it roam without proper fencing or supervision.

Buyer agrees to have the dog examined by a licensed veterinarian within 48 hours (maximum of two business days) of receipt of the dog. If the dog is determined to be in poor health, the cause of which the Seller is clearly to blame, as evidence by a veterinarian's statement, Buyer may elect to keep the dog assuming all cost's for its care, or may return the dog and all paperwork within 24 hours for a refund of the purchase price, upon confirmation of said defect as verified by Seller's veterinarian. The Seller assumes absolutely no responsibility for any fees/expenses, such as, but not limited to, caring for the dog, or transportation. Seller guarantees dog to

be in good health, free of known contagious diseases and has had vaccinations/worming required for its age at the time of this agreement. The dog will be examined by a licensed veterinarian prior to transfer of ownership from Seller to Buyer. No other guarantees are given or implied.

If at any time the Buyer is no longer able to retain possession of the dog, the Seller is to be notified and given first option of resuming full ownership of the dog in order for the Seller to locate the dog a new home. Refunds, if any, will be at the discretion of the Seller. The dog will be returned with all AKC papers and medical records. Should any circumstances arise that affect the quality of life of the dog, the Seller is to be informed. The Seller reserves the right to approve/prohibit any transfer of this animal to a third party. Under no circumstances will this dog be sold, leased, traded or given away to any pet shop, research laboratory, animal shelter or similar facility.

Buyer agrees that dog will not be taken into any public situations (i.e.: dog parks, groomers, retail stores) until dog has received 16 week check- up including vaccinations.

Buyer agrees to contact the Seller immediately if any questions or concerns arise about the dog, such as housing, diet, or health. Buyer agrees to keep the Seller informed of any treatment as it occurs; this provides the Seller important feedback and information on the health of our dogs for future generations.
